## **PRODUCT**

Allianz Global Equity Dividend (the "Fund") is established as a Germany domiciled FCP and managed by Allianz Global Investors GmbH, part of group Allianz Global Investors.

## WHAT IS THIS PRODUCT?

#### TYPE

This Fund is a UCITS according to European Directive 2009/65/EC. **TERM** 

The Fund has been set-up for an indefinite period of time. In accordance with the Fund's rules, the assets belonging to the Fund are owned jointly by the Fund's unitholders. The Management Company may terminate the Fund's management according to the Fund's rules. In this case, the Management Company / the Fund's appointed depository will either entrust its management to another management company or the depository will liquidate the Fund and distribute the proceeds to the Fund's unitholders.

You may redeem shares of the Fund usually on each business day. We usually distribute the income of the Fund on a yearly basis. The management company may suspend redemption if exceptional circumstances make this appear necessary, taking into account the interests of the investors, or limit redemption if the investors' redemption requests reach a predefined threshold above which the redemption requests can no longer be executed in the interests of the investors as a whole.

#### **OBJECTIVES**

The investment objective of the Fund is to participate in the performance of the F (EUR) unit class of Allianz Global Dividend (the "Master Fund"). To this end, the fund invests at least 95% of its fund assets in units of the master fund. The Master Fund aims to achieve long-term capital appreciation by investing in companies in the global equity markets that are expected to offer sustainable dividend payments while promoting environmental and social characteristics. At least 70% of the Master Fund's assets are invested in global equities in accordance with the Master Fund's investment objective. A maximum of 30% of the Master Fund's assets may be invested in emerging markets. A maximum of 15% of the Master Fund's assets may be held directly in deposits or invested in money market instruments or (up to 10% of the Master Fund's assets) invested in money market funds for liquidity management purposes. A maximum of 10% of the master fund's assets may be invested in target funds (UCITS and/or UCIs). The master fund is considered an "equity fund" in accordance with the German Investment Tax Act. The return is calculated on the basis of the daily calculated unit prices, which are calculated on the basis of the valuation of the assets contained in the fund.

\The Master Fund promotes environmental and social characteristics (E/S characteristics) while applying certain minimum exclusion criteria for direct investments. The fund's pre-contractual information describes all relevant information on the scope, details and requirements of the E/S characteristics and the exclusion criteria applied by the master fund.

Min. 80% of the assets held in the master fund's portfolio are valued using the "weighted average greenhouse gas emission intensity" (GHG emission intensity). The basis for calculating the 80% threshold is the net asset value of

the master fund, with the exception of instruments that are not valued by nature, e.g. cash and deposits. Derivatives are generally not valued. However, derivatives (with the exception of credit default swaps) whose underlying is a single rated corporate issuer are generally valued. The Master Fund's objective of reducing greenhouse gas emissions is taken into account to the extent that the GHG emissions intensity of the Master Fund is reduced by 5.00% annually in accordance with an anticipated schedule. The reduction of the GHG emissions intensity of the master fund by 5.00% annually is a fixed target that has been bindingly defined and calculated for the respective future financial year ends of the master fund. At least 10% of the master fund's assets are invested in sustainable investments. The minimum percentage of the Master Fund's investments that are aligned with the EU taxonomy is 0.01% of the Master Fund's assets.

Benchmark: MSCI AC World (ACWI) Total Return Net (in EUR).

The Fund's performance will be very similar to the Master Fund's performance. Derivatives may be used in the Master Fund to offset exposure to price fluctuations (hedging), to take advantage of price differences between two or more markets (arbitrage) or to multiply gains although it may also multiply losses (leverage). A derivative is a financial instrument whose value depends not necessarily 1:1 - on the development of one or more underlying assets (e.g., securities or interest rates).

We have classified this Fund as 4 out of 7, which is a medium risk class on the basis of the PRIIPs regulation. This rates the potential losses from future

performance at medium level, and poor market conditions could impact our capacity to pay you. The categorisation of the Fund is not guaranteed and may change in the future. Even the lowest category 1 does not mean a risk-free investment.

### WHAT HAPPENS IF ALLIANZ GLOBAL INVESTORS GMBH IS UNABLE TO PAY OUT?

A default by the management company has no direct impact on your payouts, as the law stipulates that in the event of the insolvency of Allianz Global Investors GmbH, the Fund does not become part of the insolvency estate of Allianz Global Investors GmbH, but remains independent.

Therefore, neither an insolvency of the management company nor of the

Fund's appointed depository will result in an investor losing money in the Fund.

In case of insolvency of the management company, the Fund's depository will either liquidate the Fund and distribute the proceeds to Fund's investors or entrust its management to another management company.

## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

## Recommended holding period: 5 years

Due to its investment strategy, the Fund's value may vary considerably over the short time. You should therefore stay invested for at least 5 years to profit from gains on the longer term. If you disinvest earlier, there is a higher risk that you might get back only poor returns, or not even the sum you invested. The Fund is open-ended which means you can redeem money back at every NAV calculation and without having to pay penalties. If applicable to your Fund you will pay the exit fees only. The detailed procedure to redeem from the Fund is described in the Prospectus.
