

Objectives: The Fund is mainly investing in stocks of companies listed or located in the European countries. In addition, the Fund may hold bank deposits as well as invest in money market instruments. The Fund is managed by several (at least two) asset managers following different investment strategies. Investment managers are selected through an evaluation process using quantitative and qualitative filters, regular personal interviews and on-site visits. The Fund continuously invests at least 51% of its assets in equities.

Intended retail investor: In the member state of origin, the product is intended for professional and private investors with a long-term investment horizon, basic experience and who are able to bear a full financial loss. The product may be used for capital appreciation.

The risk indicator assumes you keep the product until 6 years.

Performance-Scenarios:

Recommended holding period: 6 years
