# **Objectives and Investment Policy**

Templeton Growth (Euro) Fund (the "Fund") is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

• equify and equity-related securities issued by companies of any size located in any country, including emerging markets

The Fund can invest to a lesser extent in:

derivatives for hedging and efficient portfolio management

structured products (such as equity-linked notes)

The investment team uses in-depth analysis to select individual equity securities that it believes are undervalued, based on such factors as their expected long-term earnings and the value of their business assets.

The benchmark of the Fund is the MSCI All Country World Index-NR. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. #### **Terms to Understand**

**Derivatives:** Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Emerging markets: Countries whose economy, stock market, political situation and regulatory framework are not fully developed.

**Equity securities:** Securities that represent an ownership stake in a company.

**Structured products:** Packaged financial products whose value is generally linked to underlying asset(s) that are typically created to satisfy a need that cannot be met by investing solely in standard financial instruments available in the market.


# Charges
