What is this product?

This product is a share in a sub-fund of the investment company with variable capital BL, an undertaking for collective investment in transferable securities (UCITS) under Luxembourg law.

This sub-fund has no maturity date. However, the board of directors of the fund may decide to close the sub-fund under certain circumstances.

Seeking a medium-turn return exceeding a bond investment in EUR.

The sub-fund invests in shares, bonds, including inflation-linked bonds, money market instruments or cash.

The percentage of the sub-fund's portfolio invested in the various instruments varies according to the valuation of the various classes of assets and market circumstances. However, the sub-fund invests at least 25% of its net assets in shares.

In order to achieve its objective, the sub-fund may invest a maximum of 10% of its net assets in open-ended investment funds.

The sub-fund may also use derivative products for hedging purposes or in order

to optimise the portfolio's exposure.

The investment manager integrates and promotes sustainability factors within his equity investment strategy by applying non-financial data to the issuer val-uation model. In terms of bond investments, the sub-fund will be invested exclusively in securities issued or guaranteed by states aligned with the provisions of the Paris Agreement.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is aimed at investors who are looking for earnings and capital growth over a medium time period. The investor may experience losses up to the amount invested. This product is suited to investors with a basic to in-depth knowledge and experience of the product and the markets. This product is not eligible for retail investors.

Dividend income: This class is a capitalisation class meaning that income is reinvested.



What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

What happens if BLI - Banque de Luxembourg Investments is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 3 years
