What is this product?

Type

This product is a share in a sub-fund of the investment company with variable capital BL, an undertaking for collective investment in transferable securities (UCITS) under Luxembourg law.

Term

This sub-fund has no maturity date. However, the board of directors of the fund may decide to close the sub-fund under certain circumstances.

Objectives

The aim of this sub-fund is to achieve long-term capital growth by means of a diversified portfolio, while maintaining the volatility level lower than that of the equities market.

This flexible sub-fund invests a minimum of 51% of its net assets in investment funds investing in various asset classes, i.e. shares, bonds, money-market instruments or other transferable securities. The proportion of the asset classes will vary according to market circumstances. However, the weighting in shares may never exceed 50%.

The assets may be invested in money market instruments, in all types of fixed-term and/or variable transferable securities listed or traded on a regulated market and/or structured products (instruments whose value depends on different investments, including derivatives).

All investments in structured products are qualified as transferable securities and the underlyings may be composed of shares, debt securities, commodities (including precious metals), baskets of debt securities and/or shares, indices and/or baskets of stock market products.

If the sub-fund is invested in structured products on precious metals, this is done via investment vehicles which track the value of the underlying product (Exchange Traded Commodities). These products will not include derivatives and will not give rise to the physical delivery of the underlying metal. The sub-fund may invest up to 25% of its net assets in this type of instrument.

Debt securities and other equivalent securities may be issued by companies, States or other entities.

Investments are made without any geographical, sector-based or monetary restrictions.

The sub-fund may invest in derivatives in order to hedge or optimise the portfolio.

The underlying funds are selected on the basis of quantitative and qualitative criteria. The monitoring process is performed through regular contact with the

managers of each of the underlying funds in the portfolio. The objective is to use underlying funds which best meet the themes, styles, regions and representative sectors of the fund manager's convictions.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is aimed at investors who are looking for earnings and capital growth over a medium time period. The investor may experience losses up to the amount invested. This product is suited to investors with a basic to in-depth knowledge and experience of the product and the markets.

Other information

Depository: Banque de Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

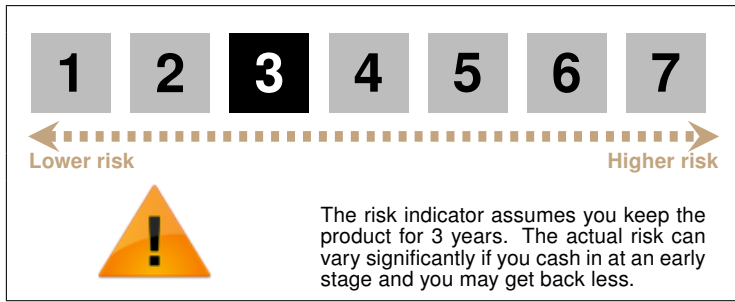

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Unfavourable scenario: This type of scenario occurred for an investment between March 2017 and March 2020, by referring to a reference class.

Moderate scenario: This type of scenario occurred for an investment between January 2016 and January 2019, by referring to a reference class.

Favourable scenario: This type of scenario occurred for an investment between December 2018 and December 2021, by referring to a reference class.

The stress scenario shows what you might get back in extreme market circumstances.

What happens if BLI - Banque de Luxembourg Investments is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 10,000 EUR is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 3.3% before costs and -0.1% after costs.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

You should be prepared to stay invested for 3 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
