# What is this product?

This product is a sub-fund of the fund BL constituted in the form of an investment company with variable capital with multiple sub-funds under Luxembourg law, subject to Part I of the Luxembourg law of December 17, 2010 concerning undertakings for collective investment.

#### Term

This sub-fund has no maturity date. However, the board of directors of the fund may decide to close the sub-fund under certain circumstances.

#### **Objectives**

Seeking a reward with limited volatility. This mixed defensive sub-fund invests in shares, bonds, including inflationlinked bonds and money market instruments.

The allocation of neutral assets in this sub-fund consists of investing around 30% of its net assets in shares.

A minimum of 15% and a maximum of 45% of the sub-fund's net assets are invested in shares.

In order to achieve its objective, the sub-fund may invest a maximum of 10% of its net assets in open-ended investment funds.

The sub-fund may also use derivative products for hedging purposes or in order to optimise the portfolio's exposure.

The investment manager integrates and promotes sustainability factors within his equity investment strategy by applying non-financial data to the issuer val-uation model. In terms of bond investments, the sub-fund will be invested exclusively in securities issued or guaranteed by states aligned with the provisions of the Paris Agreement.

Investments are made without any geographical, sector-based or monetary restrictions.

Bonds and other equivalent securities may be issued by companies, states or other entities. The underlying funds are selected on the basis of quantitative then qualitative

criteria. The monitoring process is performed through regular contact with the managers of each of the underlying funds in the portfolio. The objective is to use underlying funds which best meet the themes, styles, regions and representative sectors of the fund manager's convictions.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

#### Intended retail investor

This product is aimed at investors who are looking for earnings and capital growth over a short time period. The investors with a basic to the amount invested. This product is suited to investors with a basic to in-depth knowledge and experience of the product and the markets.

#### Other information

Dividend income: This class is a capitalisation class meaning that income is reinvested.

What happens if BL is unable to pay out?

To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.
