## What is this product?

#### Туре

The Fund is a sub-fund of an undertaking for collective investment in transferable securities ("UCITS") under European Directive 2009/65/EC. An investment company with variable capital (société dinvestissement à capital variable or "SICAV") under Luxembourg law.

#### Term

There is no fixed maturity date. An investor can hold their investment for any time period but minimum 5 year(s) is recommended. The Manufacturer can close the fund with notice.

#### Objectives

The objective is to achieve a long-term increase in the value of your investment. The Fund seeks to achieve this by investing at least 75% of its total assets in equities and equity related securities such as warrants (the right to purchase a security, usually an equity, at a specific price within a certain time frame) of European companies. The Fund will invest the majority (greater than 50%) of its assets in equities of companies that have a maximum capitalisation less than or equal to the highest capitalisation in the MCSI Europe Small Cap NR Index (Index). Equity exposure is normally well above the minimum stated level. The Fund is actively managed in reference to the MCSI Europe Small Cap NR Index (Index). The index is broadly representative of the securities in which the Fund invests, and provides a suitable comparator benchmark against which Fund performance will be measured and evaluated over time. The fund manager has discretion to select investments with weightings different to the index, and that are not in the index, and the Fund may display significant divergence from the index. There is no minimum holding period for this Fund. However, it may not be appropriate for investors who plan to withdraw their money in under 5 years.

Income from investments in the Fund will be added to the value of your shares.

You can buy or sell shares in the Fund on any day which is a business day in Luxembourg unless the directors have decided that insufficient markets are open. 
#### Intended retail investor

This fund is aimed at Retail and Professional customers and Eligible Counterparties who should have at least a basic level of knowledge and experience of investing in funds. It is designed for investors looking for capital growth who can invest their money for at least 5 years. Your capital is not guaranteed which means that investors could lose up to 100% of the amount invested. The fund invests in company shares, the prices of which tend to fluctuate more than other asset classes, as investors directly participate in underlying companies and their profits and losses.

The risk indicator assumes you keep the product for 5 year(s).
