Objectives: The sub-fund is exclusively investing in cleantech companies, mainly stocks listed in developed markets. Cleantech can be defined as products and services that provide cleaner or more efficient use of the earth's natural resources, such as energy, water, air and raw materials. The sub-fund focuses on cleantech companies in areas such as renewable energy, energy efficiency, water treatment, waste management, pollution control and advanced materials. On an ancillary basis, the sub-fund may invest in stocks of cleantech companies listed in emerging markets as well as in convertible bonds issued by cleantech companies. This is a sub-fund with environmental and/or social characteristics (Art. 8 Regulation (EU) 2019/2088, Disclosure Regulation). The sub-fund integrates environmental, social and governance (ESG) considerations in the investment strategy of the sub-fund. ESG is implemented in the investment strategy through the thematic approach as indicated above. Additionally, ESG sustainability factors are integrated in the portfolio construction and stock selection process and exclusion factors are applied to sectors and activities with major ESG sustainability risks.

Intended retail investor: In the member state of origin, the product is intended for professional and private investors with a long-term investment horizon, basic experience and who are able to bear a full financial loss. The product may be used for capital appreciation.

Performance-Scenarios:
