WHAT IS THIS PRODUCT?

Type: Undertaking for Collective Investment in Transferable Securities (UCITS) under European Directive 2009/65/EC. An investment company with variable capital (société d'investissement à capital variable or "SICAV") under Luxembourg law.

Term: This product is not subject to any fixed term.

Objectives: The sub-fund's objective is to deliver a greater total return than the Consumer Price Index (CPI) measure of inflation + 3%, after fees, over any rolling five-year period by investing with the Liquidity, Equity-type risk and Diversifiers assets (LED) framework developed by the investment manager. The sub-fund aims to deliver this return with no more than two thirds of the volatility of the FTSE Developed Market Index. There is no guarantee that the sub-fund will achieve a positive return over this, or any other, period and you may not get back the original amount you invested.

Intended Retail Investor: This product targets Retail and Professional investors and as a minimum requirement, is suited to a

first time investor with a basic knowledge of investments. This product targets investors who intend to invest their money for a minimum period of 5 years. Rathbones defines the minimum recommended holding period of 5 years as Long Term. This product has no capital guarantee and investors may not get back the original amount invested. This product is appropriate for investors who have a risk appetite compatible with the SRI of the product as defined in the Prospectus. This product may be distributed as follows: on an execution only basis without a suitability assessment; with investment advice; or, as a component of a managed portfolio.

The depositary is HSBC Continental Europe, Luxembourg. WHAT ARE THE COSTS?

COSTS OVER TIME
