What is this product?

This product is a sub-fund of the fund BL constituted in the form of an investment company with variable capital with multiple sub-funds under Luxembourg law, subject to Part I of the Luxembourg law of December 17, 2010 concerning undertakings for collective investment.

Term

This sub-fund has no maturity date. However, the board of directors of the fund may decide to close the sub-fund under certain circumstances.

Objectives

Seeking a medium-turn return exceeding a bond investment in EUR.

The sub-fund invests in shares, bonds, including inflation-linked bonds, money market instruments or cash.

The percentage of the sub-fund's portfolio invested in the various instruments varies according to the valuation of the various classes of assets and market circumstances. However, the sub-fund invests at least 25% of its net assets in shares.

In order to achieve its objective, the sub-fund may invest a maximum of 10% of its net assets in open-ended investment funds.

The sub-fund may also use derivative products for hedging purposes or in order to optimise the portfolio's exposure.

The investment manager integrates and promotes sustainability factors within his equity investment strategy by applying non-financial data to the issuer valuation model. In terms of bond investments, the sub-fund will be invested exclusively in securities issued or guaranteed by states aligned with the provisions of the Paris Agreement.

Investments are made without any geographical, sector-based or monetary restrictions.

Bonds and other equivalent securities may be issued by companies, states or other entities.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is aimed at investors who are looking for earnings and capital growth over a medium time period. The investor may experience losses up to the amount invested. This product is suited to investors with a basic to in-depth knowledge and experience of the product and the markets. This product is eligible for retail investors under a remunerated management or advice mandate entrusted to a credit establishment or investment company by the investor. The conditions of eligibility for this product are described in the prospectus.

Dividend income: This class is a capitalisation class meaning that income is reinvested.
