## What is this product?

#### Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

#### Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

#### Objectives

The objective of the sub-fund is to generate return and capital appreciation in the long term by investing mainly in equity instruments.

The sub-fund mainly invests in investment funds including Exchange Traded Funds (ETF) investing in equities, bonds, money market instruments and/or liquidities. The equity exposure of the investments represents at least 50% of the sub-fund net assets. The investments are not subject to geographical, sectorial or monetary limitations.

The Investment manager's investment policy relies on a monthly Investment Committee that defines the asset allocation within the portfolio, taking into account different aspects as the stocks and bonds markets and the geopolitical and macroeconomic environment. The Portfolio is then implemented into well recognized financial instruments (as UCITS Funds, ETFs or stocks/bonds quoted on recognized markets as Euronext or the New-York Stock Exchange). Every financial instrument has been through a strict Due Diligence process (quantitative and qualitative).

The sub-fund may also invest up to 25% of its net assets in:

- Direct stocks / shares of companies or holdings quoted in a regulated market of the OECD countries, with specific focus on European and United States markets.

- Investment funds including Exchange Traded Funds (ETF) with other investment strategies, including but not limited to long-short strategies and/or real estate.

- Exchange Traded Commodities (ETC) on precious metals provided that such products do not contain embedded derivatives and do not give rise to a physical delivery of the underlying metal.

The sub-fund may in a minor sense (up to 15%) invest in regulated UCITS Funds (or ETFs), managed by well recognized companies, with a main focus on Chinese markets.

The sub-fund may, use financial derivative instruments for efficient

portfolio management and hedging purposes.

**Benchmark:** The portfolio is actively managed on a discretionary basis without reference to a benchmark.

#### Intended retail investor

This product is designed for investors who are willing to achieve income and capital growth and have a medium to long term horizon. The investor can bear losses up to the invested amount. This product is appropriate for investors with a basic to advanced knowledge and experience of the product and the markets.

#### Other information

**Depositary:** Banque de Luxembourg

**Dividend income:** This class is a capitalisation class meaning that income is reinvested.

**Conversion right:** The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

**Segregation:** The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

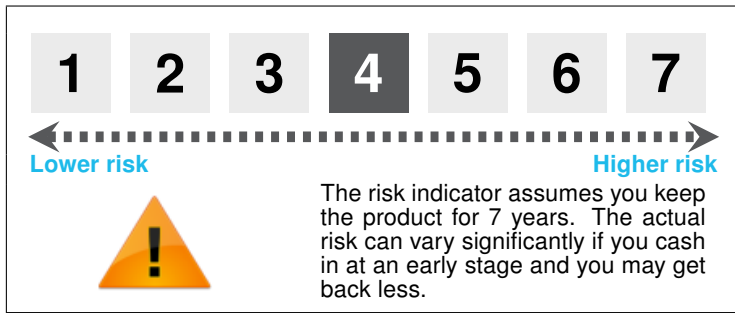

Risk of underlying funds

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

Moderate scenario: This type of scenario occurred for an investment between December 2013 and December 2020, by referring to a benchmark.

Favourable scenario: This type of scenario occurred for an investment between September 2011 and September 2018, by referring to a benchmark.

The stress scenario shows what you might get back in extreme market circumstances.

## What happens if ESTATE ALLIANCE is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. **Recommended holding period: 7 years**
